

### **FAPPANI IS NRHA'S FIRST \$9 MILLION RIDER!**

Just one year after becoming the National Reining Horse Association's first-ever \$8 Million Rider, Andrea Fappani has etched his name in the history books once again as the first rider to surpass \$9 million in earnings. This remarkable accomplishment coincides with his induction into the NRHA Hall of Fame, marking 2024 as another defining year in the career of NRHA's all-time leading rider.

An NRHA Million Dollar Owner, Fappani has remained at the pinnacle of the reining industry for over two decades, continually enhancing his already remarkable legacy. Raised on a dairy farm in Bergamo, Italy, Fappani's love for horses began as a shared passion with his father, quickly igniting a lifelong dedication. He moved to the United States to further pursue his reining career and went out on his own in 2003. By 2006, Fappani had made history as the youngest NRHA Million Dollar Rider at that time.

When Fappani entered the arena during the 2024 High Roller Reining Classic Level 4 Open Stakes and Derby, he had \$8,996,771 in NRHA Lifetime Earnings (LTE). Earlier in the week, he took home the Level 4 Open Futurity on Its Wishful Thinking (Spooks Gotta Whiz x Black Custom Chex), owned by Mary Cachat, and took home fourth and 11th place on two additional mounts. He crossed the \$9 million milestone on Vintage Chex (A Sparkling Vintage x Chex Out The Cowgirl) after scoring a 226.5 to take the Open Derby and 4-Year-Old Stakes Championships, adding \$30,219 to their record. The stallion is bred, nominated, and owned by Bill Coburn, who has been part of Fappani's program for 20 years.

Since becoming the first NRHA \$8 Million Dollar Rider, Fappani's highest earning performances on his way to \$9 million include:

2023 NRHA Futurity Level 4 Open Reserve Champion aboard Inferno Thirty Five (Inferno Sixty Six x Madeof Pure Spangled), bred by Cardinal Hill Training Center LLC, nominated by Mary Jansma, owned by Stephen Archer, earning \$142,500



### FOUR PHENOMS CROSS MULTI-MILLION DOLLAR SIRE MILESTONES

After big performances by offspring at The Run For A Million and the 100X Reining Classic, four stallions crossed multi-milliondollar milestones with the NRHA: Topsail Whiz, Magnum Chic Dream, Spooks Gotta Whiz, and Pale Face Dunnit.

Topsail Whiz – NRHA \$13 Million Sire

Bred by Tom McBeath, Topsail Whiz (Topsail Cody x Jeanie Whiz Bar) was owned by Bob Loomis Reining Horses. Loomis rode the late sire to nearly \$50,000 in NRHA Lifetime Earnings (LTE) during his show career. During the 1990 NRHA Futurity, the duo rode to their top finish—the Level (L) 4 Open Championship.

Topsail Whiz was inducted into the NRHA Hall of Fame in 2003 and has continued to leave his mark on reining through remarkable offspring. The stallion has more than 1,000 offspring with NRHA LTE. Several of his progeny have contributed to this newest milestone, including his second-highest earning offspring—Dun It For Whizkey.

Dun It For Whizkey helped Topsail Whiz cross his last historical milestone after top finishes at the NRHA Futurity and Derby. Since then, he's added nearly \$55,000 more toward his sire's offspring earnings. Nearly half of that total came during the 2019 The Run For A Million, where he and NRHA Million Dollar Rider Franco Bertolani earned a ninth-place finish in the Million Dollar Competition.

Rhodes River Ranch, \$216,336 NRHA LTE Smoking Whiz (out of Glendas A Smokingun), bred by Susan Ray, owned by Silver Spurs Equine, \$208,839 NRHA LTE

#### Magnum Chic Dream – NRHA \$12 Million Sire

NRHA Hall of Famer Magnum Chic Dream is making history once again as an NRHA \$12 Million Sire after only crossing the \$11 million mark a mere five months prior. The Guy A Du Ponchel-bred stallion, by NRHA Hall of Famer Smart Chic Olena and out of Sailin Barbee, garnered \$44,294 in NRHA LTE for owner Viola Scott. With NRHA Million Dollar Rider Casey Hinton at the reins, the stallion was crowned 2004AQHA Senior World Reining Champion, his most notable title within his show career.

The breeding shed is where Magnum Chic Dream continued to leave his mark on reining. His progeny have competed and earned top titles in nearly every facet of reining competition, including the NRHA Futurity, the NRHA Derby, the National Reining Breeder's Classic (NRBC), and the World Equestrian Games. To date, 28 of his offspring have over

\$100,000 NRHA LTE.

Custom Dreams (out of Gunna Be Custom) has led the charge to push Magnum Chic Dream over the \$12 Million Sire milestone. Owned by Custom Dreams Brazil, the Devin Warren-bred and -nominated stallion has earned nearly \$215,000 this year, including a \$100,000 paycheck at the 100X Cowtown Classic where he and Deary won the L4 Open Stakes. They went on to earn top marks at the 2024 6666 NRHA Derby presented by Markel with a reserve championship in the Tamarack Ranch Open 4-Year-Old Stakes, a first-place finish in the American Paint Horse Association (APHA) Chrome Cash division, and sixth place in the L4 Open Derby.

#### Spooks Gotta Whiz – \$9 Million Sire

Michell Anne Kimball's Spooks Gotta Whiz (Spooks Gotta Gun x Prettywhizprettydoes) was bred by Clint Haverty. With NRHA LTE of nearly \$350,000, the 2007 stallion is one of only a few to win the NRHA L4 Open Futurity, the NRHA L4 Open Derby, and the NRBC. He also earned two gold medals at the 2014 World Equestrian Games. Spooks Gotta Whiz entered the show pen at the 2024 The Run for Million with NRHA Hall of Famer Shawn Flarida at the reins, proving that at 17 years old, the stallion still loves the limelight in the show pen.

Now, Spooks Gotta Whiz is making an even bigger mark on reining, which was solidified with his induction into the NRHA Hall of Fame in 2022.

His top-earning offspring, Mic Dropp, has helped usher him to \$9 million with a thirdplace performance in the Million Dollar Competition at The Run For A Million last month. The performance led to a \$90,000 paycheck with NRHA Hall of Famer Andrea Fappani at the reins. Fappani has piloted the stallion his entire show career.

#### Pale Face Dunnit – \$4 Million Sire

With the parentage of NRHA Hall of Famer and All Time Leading Sire Gunner and Lena Dun It, Rancho Oso Rio LLC bred Pale Face Dunnit to be a reining superstar. The Schmersal Reining Horses and Silver Spurs Equine-owned stallion garnered over \$70,000 in NRHA LTE.

The 2007 sire had his first crop of foals in 2012. After crossing his last historic milestone in 2022, Pale Face Dunnit's over 340 NRHA money-earning offspring have now made him a \$4 Million Sire.

One of the offspring pushing him to this new milestone is TA Dunit Redhot, a 6-year-old stallion out of Redhot Walla owned by Hickory



Creek Ranch LLC. With NRHyA member Addisyn Schmersal at the reins for nearly all of the stallion's career, he amassed \$145,901 NRHA LTE with wins including a reserve championship at the NRBC L4 Non Pro and a championship in the L3.

## IN LIKE FLINN JOINS THE RANKS OF NRHA MILLION DOLLAR SIRES

Attesting to an exceptional lineage, performance in the show pen and the success of his progeny, In Like Flinn has solidified his place in the history books as an NRHA Million Dollar Sire.

Bred by Buck Hazledine and owned by In Like Flinn Holdings LLC, this 2010 stallion, by NRHA Hall of Famer Topsail Whiz and out of Nestle Quik Chic, was destined for greatness.

In Like Flinn boasts an impressive show career, amassing \$187,880 in NRHA Lifetime Earnings (LTE). His most notable performance includes a 4th place finish at the 2013 NRHA Level 4 Open Futurity with NRHA Million Dollar Rider Nathan Piper in the saddle. Throughout his career, he also demonstrated his versatility and excellence in the arena with NRHA \$4 Million Rider Casey Deary and 2021 Becky Hanson Horsewoman of the Year, Kaci O'Rourke.

Standing at Cedar Ridge Stallion Station, In Like Flinn has sired 108 NRHA money-earning offspring to date, collectively contributing to his newly earned Million Dollar Sire status. His progeny have consistently shown outstanding ability and athleticism, furthering his legacy and cementing his influence on the sport of reining.

After achieving success on In Like Flinn, Deary continued to showcase the stallion's legacy by riding his top-earning offspring, Time Inn A Bottle. The duo rode to 8th place at the 2022 NRHA Level (4) Open Futurity. NRHA Non Pro Jack Medows also guided the gelding to over \$37,000 in earnings. With the two talented pilots at the reins, Time Inn A Bottle has recorded over \$93,000 in NRHA LTE for owner, breeder, and nominator Amy Medows.

### THIS CHICSDUNDREAMIN IS NRHA'S NEWEST MILLION DOLLAR DAM Photo and Press Release provided by NRHA

In a year where mare power is more evident than ever, the National Reining Horse Association announces the 12th Million Dollar Dam, This Chicsdundreamin. This is the fourth mare to reach this elite milestone in 2024, which is twice as many as any year in history.

Bred by the late Joe Hayes, the 20-year-old mare was owned by George Lawrence and Judy Box before finding her current home at Rhodes River Ranch. She is by NRHA Hall of Famer Magnum Chic Dream and out of Hermosa Dun It.

This Chicsdundreamin amassed \$124,609 in NRHA Lifetime Earnings (LTE) while competing simultaneously with George Lawrence in non pro divisions and NRHA \$4 Million Rider Casey Deary in open divisions. Although Lawrence owned her at the time, both men would often show her and earn money at the same events. including Reining By The Bay, the National Reining Breeders Classic (NRBC), and the Wimpys Little Step Derby. The mare's top finish came with Lawrence during the 2009 NRBC, where the duo won the Level 3 Non Pro and earned 3rd in the Level 4.

The mare now has 20 offspring, with 15 having NRHA LTE. Topping that list with nearly half a million in NRHA LTE is Tinker With Dreams. Bred and nominated by Rhodes River Ranch, Tinker With Dreams is owned by NRHA Corporate Partner Diamond Dub Quarter Horses. The 10-year-old stallion was runner-up at the 2023 The Run For A Million's Million Dollar Competition with NRHA Million Dollar Rider Dany Tremblay at the reins. The duo competed in the competition again this year and earned \$35,000 to push the stallion's dam over the million-dollar mark.


### HANGTEN SURPRIZE BECOMES NRHA MILLION DOLLAR SIRE

Hang Ten Surprize has officially reached the coveted status of National Reining Horse Association Million Dollar Sire.

Born in 2000 and bred by Bob Loomis Quarter Horses Inc., Hang Ten Surprize's lineage is rooted in excellence. He is sired by Hangten Peppy and out of Mizzen Topsail. Over the years, Hang Ten Surprize has been owned by several notable reining enthusiasts, including Bob Loomis Reining Horses, Manntana LLC, and Hang Ten Surprize LLC. In 2015, NRHA Hall of Famer Dell and Terri Hendricks acquired the stallion, continuing his legacy under their ownership.

With \$133,059 in NRHA Lifetime Earnings (LTE), Hang Ten Surprize was a force to be reckoned with in the reining arena. Ridden exclusively by NRHA \$2 Million Rider Duane Latimer, Hang Ten Surprize achieved remarkable victories throughout his career. Among his most notable accomplishments, he claimed the Individual Reining title at the 2006 World Equestrian Games. He also earned the distinction of 2004 American Quarter Horse Association Jr Reining World Champion.

While Hang Ten Surprize had a stellar show career, it is his impact as a sire that has now propelled him into the NRHA Million Dollar Sire club. With 129 offspring boasting NRHA earnings, his progeny consistently demonstrate excellence in the arena. His top-earning offspring, Hang Ten And Shine—out of NRHA Hall of Famer Ebony Shines—has earned \$117,582 in NRHA LTE. Bred and nominated by NRHA Hall of Famer Rosanne Sternberg and owned by Christine Brazeau, Hang Ten And Shine has achieved impressive finishes at major events, including 12th place at the 2014 NRHA Level (L) 4 Open Futurity, eighth place at the 2017 National Reining Breeders Classic L4 Open



and third place at the 2017 NRHA L3 Open Derby.

### **THE HELP** BY NICOLE DEARY



As a business owner do you always have a "HELP WANTED" sign in front of your store, or perhaps a post on the modern-day store front - social media? Do you remember being the help?

Maybe you are a business owner, an employee, young and you want to own a company one day, or you're retired and you've made your fortune and you could give us all advice... this article is for you.

Hall of Famer, Million Dollar Rider, Olympic Gold Medal Athlete ... all these heroic individuals have something in common. They have help - extremely good help. I will venture bravely to say the help is the unsung hero that knows a tremendous amount about their employer or significant person, and they know how to create pressure or motivation to draw greatness out of the individual under the spotlight.

The help has a large meaning. I am referring to the person or people that support and work towards the victory. The help is behind the scenes, working. The help can be the coach, the wife, the golf caddy, the husband, the loper, the groom, the employee, or the parent. Some of these people are in a paid position, some are not. The greatest help gives selflessly, consistently, and regardless of circumstances or financial compensation with a great attitude. They listen to instructions well and find where they can solve a problem taking initiative without being asked. The greatest help does not need to have his or her name in lights or hold the trophy proudly on a platform.

#### How Do You Treat the Help

So, I ask the question, how do you treat your help? How do you treat your coach? Do you feed what's feeding you? Do you show gratitude, patience, kindness, respect, goodness, towards the humans helping you? Or are you constantly at battle with frustrating people who can't listen, and you repeatedly say, "I will just do it by myself!"?

Isn't it ironic in the horse business, we sometimes hear, "The horses are the easy part. The humans are the most difficult part in running a large horse operation."

Yet, we cannot accomplish the major victories without other helpful humans. If we need the people around us to reach the highest heights and accomplish the biggest dreams, then it's time to evaluate how we treat the help, and the quality of help that is near us. Ask yourself, do you treat the people in your inner circle, the people close to you (in your house, in your barn, in your office, the people working under your authority, people you see every single day), the worst? Do you treat the people in your outer circle the best?

Outer circle meaning the customer visiting your facility, the new sponsor/company owner, the horse shopper that is flying in on their private jet to buy a new horse. You get the idea.

Do you have enough self-control to treat your inner circle of people, your greatest help, with gratitude? Or do you dump all of your angers and frustrations onto them because you know they are loyal and will continue helping you unconditionally?

#### Balancing the Scales with Employees.

When my husband, Casey Deary, and I started our horse training business, we were advised that, as the boss, you should never eat meals with the help. This was shocking to us; we enjoyed the company of the people that worked on our ranch. We did not however understand the fine line of giving too much and balancing the respect. At one point the kindness became a fault and there was one young lady who had made numerous large mistakes while at work with young horses, and then was dishonest. Her remark to another employee was, "It's alright, Deary never fires anyone."

Ironically soon after, Casey was on a podcast with Andea Fappani, and he presented numerous respectful comments and questions regarding Team Deary employees staying for many years and developing excellent careers.

Also, I discussed this topic with another respected friend in the industry, whose husband had recently won The Run for A Million. She told me, "If our fault in the industry is being too kind and forgiving employees too quickly, I will gladly take that fault".

This was an eye-opening remark that caused Casey and I to set stronger boundaries.

#### 90-day Wonder

There is something excellent about new people coming to work and learning the ways of the company. Generally, they are genuinely happy and to come to work and give their best <sup>13</sup> efforts; after all they interviewed/requested to have that job, and they believed it was the greatest place to be for their career. Everyone seems to act positive and try their hardest, making the best first impression that they know how.

This is called the "90-day Wonder" according to a long term client whose family business built and sold multiple car dealerships and land investments in United States.

If you are a new employee on a new job, are you able to push past the "90-day wonder" timeline and continue to give your best efforts and help others on your job for 180 days, 365 days or even 1,825 days and stay with a company five years?

This is extremely rare in our horse industry, and yet it speaks high volumes about an individual's loyalty, honesty, work ethic, and pleasant attitude.

In addition, these first 90 days of work are a critical time to teach new employees the standards of your company's agenda and steps towards success. Assuming people will take initiative on certain jobs is a mistake and leads to disappointments. Taking the time to communicate clearly and respectfully is important and decreases mistakes or lost time and money. When dealing with new helpers in life, family, or employer, or employee, be honest and communicate clearly for the greatest rewards and benefits.

#### **The Greatest Work Environment**

When it comes to interviews, resumes, and careers, please do your research and study the company and the humans that you would like to work with.

Don't judge the book (or the FaceBook) by the cover. Take the time to check with previous employers and study the social media posts where people are presenting themselves. What do you believe you will give to the team and what do you hope the team will give to you? Can you add value to the company?

Know the questions to ask potential help.

Company owners, I highly recommend writing down the specific areas where your company has weaknesses and truly needs help. What personality do you work best with?

Do you lead by example and treat people the way you want to be treated? Have you ever been to an incredible ranch, barn, or office and studied how the people worked together and what made them successful?

### THE 40TH ANNUAL SWRHA FUTURITY DEADLINE OCTOBER 1!



It's time to get those entries in for the Southwest Reining Horse Association Futurity and Show, set this year for October 18-25. The deadline for both futurity and ancillary entries is October 1, as is the stall deadline, so it's time to get those entries and stall requests in.

Last year, the show debuted an innovative new format, with both the Open and the Non Pro futurities being held at the beginning of the show instead of the end.
